

Summer Programs for Young Adults

We are launching two exciting programs in June 2016 for teens and young adults! These programs are specifically designed for individuals who intend to live independently, seek competitive employment and/or attend a vocational training program or college upon graduation from secondary school. Both programs are free of charge.

First Jobs Program

This unique vocational program, held at Chicago Lighthouse North, in Glenview, offers a one-week training program which can lead to competitive employment at one of two identified job sites. Students will attend classes in resume writing, job vs. career, disability disclosure, nonverbal communication skills, self-advocacy, conflict resolution and mock interviewing during the morning. The afternoons will be spent orienting to and exploring the two identified job sites prior to interviewing at one of the sites.

Transportation to and from the job sites will be provided from The Chicago Lighthouse North June 13-17. If hired after June 17th, each individual will be responsible for providing his/her own transportation to and from the job site.

Summer in the City (SitCity)

This unique residential program, held at ICRE-Wood (Illinois Center for Rehabilitation and Education) in Chicago, offers a five-night experience. Students will attend classes in technology, mobility, communication and daily living skills. The evenings will be spent exploring and experiencing all the excitement that Chicago has to offer, including theater, boating, sports venues, restaurants and more.
