



WHOLE FOODS INTRODUCES THE LIGHTHOUSE TO BRAND NEW FRIENDS

Last year, Whole Foods gave The Chicago Lighthouse the invaluable opportunity to connect with potential new friends throughout the state. The Lighthouse partnered with Whole Foods through their *One Dime at a Time* campaign. Mary woke up one morning last January to a blurry world. Her doctor informed her that it was caused by macular degeneration and that it would continue to worsen. Mary sank into a deep depression and climbed back into bed, where she remained for several months.

Then, her doctor recommended that she visit The Lighthouse. Our Low Vision Clinic provided the specialized vision care she needed. She was also introduced to the assistive technology that could help her regain her independence. At our Senior Center, she learned to use that technology effectively while also receiving the emotional support she needed.

FORGING NEW FRIENDSHIPS COLLABORATIONS LEAD TO MULTI-DISCIPLINARY SOLUTIONS

The Chicago Lighthouse always seeks new partners who share our passion and dedication to our mission. Last year, we developed new relationships with IIT, Johns Hopkins, The University of Texas at Dallas, and the University of Chicago. **We are collaborating on an innovative project, the Intra Cortical Visual Prosthesis (ICVP), an implant designed to help understand how stimulation to the visual centers of the brain relates to visual perception.**

The Lighthouse's Low Vision Laboratory at our downtown facility will be the testing site to evaluate study participants once the ICVP has been implanted. Currently, we are holding educational seminars to inform potential participants about the research so they can learn more about taking part in the study.

We are already finding additional new ways to collaborate and strengthen these new partnerships. In fact, The Lighthouse has begun working with Johns Hopkins to launch another initiative to create a functional assessment tool for people with very low vision.



Last fall, Geon Ho Lee's entire family journeyed with him from South Korea to The Lighthouse, where he learned to use the BrainPort V100 vision device. This innovative device helps people who are blind perceive the world through stimulation on their tongue. While here, the Lee family toured Lighthouse Industries, where Geon Ho met people who are blind, who are as productive and independent as he aspires to be when he grows up. Our talented staff even made a special clock for him, featuring his favorite Asian cartoon character.





THE MESSAGE OF GOOD WORK TRAVELS FAST

The Lighthouse has cared for its clients for over a century, so it is natural for us to also care for customers. In 2012, we brought our talent for care to the field of customer service through our partnership with the Illinois Tollway. **Through this partnership, we manage the Tollway's customer service call center while also creating employment opportunities for the people we serve.**



ONE PARTNERSHIP LEADS TO ANOTHER

Last fall, the Illinois Tollway demonstrated its support for our continuing partnership by voting to approve a five-year contract renewal. Our partnership with the Tollway has benefitted The Lighthouse and our clients in an unexpected way, as well.

One day last year, a staff member at Cook County Health and Hospital System called the Illinois Tollway. He was so impressed by the exemplary service he received from our agent that he told his colleagues. Word spread, and soon we received a phone call from John Prendergast, Operations Director of Patient Support at Cook County. He wanted a customer care center that could deliver that same level of service.

Thus, we launched our Cook County Call Center in June of 2017. It employs twelve dedicated agents, two of whom are visually impaired. They are supervised by Robin Baker, a Veteran who is also visually impaired. "Our goal is to offer excellent service while addressing the needs of all our customers," said Robin. "Our team is highly committed to their jobs." Their commitment is paying off; three agents have already been promoted.



When Cecil became legally blind due to glaucoma, he felt like the world was suddenly very bleak. After two years without work, Cecil came to The Lighthouse and experienced hope. With our assistive technology and training, he was able to work again and was hired as an agent in our Illinois Tollway Customer Care Center.

"The Chicago Lighthouse has been an inspiration and a benefit in my life and in my family's life," he recently said. "They gave me an incredible opportunity to be the best I can be."




