# From President/Executive Director, Dr. Janet Szlyk

I'm pleased to report that The Chicago Lighthouse's Dedication Ceremony on September 29th was a smashing success! Nearly 200 guests joined us for a lively and festive celebration in which we formally dedicated our newly expanded building that will be home to many innovative and cutting edge programs in vision care. The event marked the successful completion of a \$5 million expansion and renovation project that enabled us to both grow current services and add new ones. For this, we owe a tremendous debt of gratitude to our many generous donors. Without their foresight, devotion and headstrong support, the project would not have been completed.

Highlights of the new wing include our state-of-theart Tools for Living Store and Rehabilitation Center that works in conjunction with our vision rehabilitation service. The core of the rehabilitation program is The Sandy and Rick Forsythe Center for Comprehensive Vision Care, that includes low vision services, instruction in adaptive technology options, occupational therapy, and a research laboratory pioneering new therapeutic techniques. In addition, we offer psychological counseling through The Bergman Institute for Psychological Support. We are also proud to be the home of the new Pangere Center for Inherited Retinal Diseases. Together, all three offer a system of rehabilitative care that is unsurpassed anywhere!

As a result, The Chicago Lighthouse will be better positioned to serve people who are blind or visually impaired, as well as offer hope to

members of the massive baby boom generation experiencing vision loss in the years ahead.

Of all the inspirational and courageous remarks that day, I'd like to reference comments from our keynote speaker, Steve Pangere, an Indiana businessman who operates his own construction firm. Mr. Pangere, who is visually impaired, and his wife, Georgiann, were so impressed by the work done by the Lighthouse that they are funding the agency's new Pangere Center for Inherited Retinal Diseases. The new center is headed by world renowned ophthalmologist Dr. Gerald Fishman who recently relocated his practice here.

Mr. Pangere noted that with the new addition, The Chicago Lighthouse will not only be able to provide endless opportunities, resources and training but is now offering a new dimension of hope!

I invite you to visit our newly expanded building and am confident that you'll agree that The Chicago Lighthouse is well positioned as an agency to deliver optimal programs in education, rehabilitation and employment – in fulfillment of our long standing mission. Moreover, our world class programs and staff will guarantee a growing presence on the international stage.

### Lighthouse Retail Programs

Creating Jobs and Setting New Standards in the Retail and Convenience Store Industries

In an effort to expand job opportunities as well as offer a wide array of innovative products for people who are blind or visually impaired, The Chicago Lighthouse has launched two new retail ventures; a Tools for Living Store and a

convenience store. Both state-of-the-art facilities, which have received national media coverage, were especially designed to accommodate the needs of individuals with visual impairments. The Tools for Living Store is located near the front entrance in the Lighthouse's headquarters on Roosevelt Road, while the convenience outlet is on the corner of Harrison and Ashland Avenues on the Rush Medical Campus.

The convenience store, developed through a partnership with Midwest Orthopaedics, provides three permanent staff positions to people who are visually impaired. In addition, it serves as a training facility for retail/customer service internships. The store offers customers a variety of products, including fresh sandwiches/salads, fresh baked goods, candy, snacks, drinks, greeting cards, magazines and gift items. ATM services are also available.

"At a time when our economy is struggling and we're coping with a record high unemployment rate, The Chicago Lighthouse and Midwest Orthopaedics are so very pleased to have been able to create new jobs, especially for people who are blind," said Dr. Janet Szlyk, the Lighthouse's president and executive director. She noted that the store is overseen by Rob Cancilla, program director, who is also visually impaired. "Rob has done an exceptional job in developing the store and the program from the ground up," she maintained.

While serving a largely sighted customer base, Cancilla pointed out that the store is visually stunning while specially designed to accommodate the needs of blind workers. "Our hope is to provide opportunities for on-the-job and customer service training for people who are visually impaired," he stated. "With the blind and visually impaired community grappling with an unemployment rate of nearly 70%, finding employment for those with visually impairments is our number one job!"

Elbert Ford, store manager, started with the Lighthouse's school for children with multiple disabilities then moved into the agency's job placement department and Midway Airport Kiosk operations. Ford was promoted to store manager where he oversees both the Midway Airport Kiosk as well as the new convenience store.

## **The New Pangere Center for Inherited Retinal Diseases**

A world-renowned Ophthalmologist and Researcher brings his practice to the Lighthouse

The Chicago Lighthouse took another big step forward in vision care by recently unveiling the new Pangere Center for Inherited Retinal Diseases. Serving as director of the new facility is Dr. Gerald Fishman, a world renowned physician, researcher and academic who relocated his practice to the Lighthouse this past September.

"He is a superb addition," said Dr. Janet Szlyk, the Lighthouse's president and executive director. "Routinely cited as one of Chicago's top physicians, Dr. Fishman brings his expertise in hereditary retinal diseases and knowledge of electrophysiological and psychophysical testing procedures to our agency where he'll continue to care for patients as well as pursue his clinical research on various inherited retinal diseases."

The center, housed in extensively remodeled space formerly occupied by the Lighthouse's low vision clinic, is named in honor of Steve and Georgiann Pangere. Steve is an Indiana businessman who operates his family's construction company. Pangere, who is visually is

#### RENOWNED CHICAGO ATTORNEY PAUL W. RINK JOINS THE KANE LEGAL CLINIC

The Chicago Lighthouse Kane Legal Clinic has added prominent Chicago attorney and Lighthouse board member Paul W. Rink to assist Judge Nicholas Pomaro in providing pro bono legal services to people who are blind or visually impaired. Mr. Rink has many years of legal expertise with a distinguished career in law and state government. Totally blind since birth, he recently retired as a commissioner from the Illinois Worker's Compensation Commission. It is believed that he was the first blind commissioner of that agency in Illinois history. Mr. Rink has attained many notable personal and professional achievements, including being the first blind member of his class at Loyola University Chicago to graduate with honors.

# SENATOR DURBIN, PANEL DISCUSSION HIGHLIGHT LIGHTHOUSE ADA TRIBUTE

The Lighthouse marked the 20th anniversary of the signing into law of the Americans with Disabilities Act on July 26th with special remarks from U.S. Senator Richard Durbin, one of the Act's original supporters, and a panel discussion. The event, which attracted over 100 representatives from Chicago's disability community, received coverage from ABC 7, the *Chicago Tribune*, *Chicago Daily Law Bulletin*, Illinois Radio Network and others.

Following the Senator's comments, the panel discussion was moderated by Judge Nicholas Pomaro; and included Illinois Supreme Court Justice Anne Burke, Rene Luna, disability advocate with Access Living in Chicago; Paul Scher, a Lighthouse board member; Ray Campbell, who operates the Lighthouse's Adaptive Technology Help Desk; Mary Abramson, instructor in the Lighthouse's Office Skills program; and Emily Norris, a third year law student at the University of Illinois College of Law.

#### PRESIDENT OBAMA APPOINTS FORMER CHICAGO LIGHTHOUSE PRESIDENT JAMES KESTELOOT

In August, President Obama appointed former Chicago Lighthouse President and Executive Director James M.
Kesteloot as Member, Committee for Purchase From People Who Are Blind or Severely Disabled, the independent federal agency that administers the AbilityOne Program. The Program's mission is to provide employment opportunities for people who are blind or have other severe disabilities in the manufacture and delivery of products and services to the federal government.

The Lighthouse hosted an ice cream social for our 2010 Scholarship winners on Saturday, July 24th. This year, the Scholarship Program gave \$59,000 in awards to 28 individuals from across the country. ### SEEING WHAT'S POSSIBLE DINNER A GREAT SUCCESS

Citing their innumerable contributions to the city's civic and charitable life, The Chicago Lighthouse saluted philanthropists Judy and Ray McCaskey with the agency's prestigious "Beacon of Life Award" during its annual "Seeing What's Possible" dinner on May 20th.

The event, which took place at The Four Seasons Hotel, attracted 520 supporters while raising \$225,000 for Lighthouse programs to assist people who are blind or visually impaired.
